PRODUCT INFORMATION

Description

Tremco SF200 Carpet Tile Tackifier is a single component, white waterborne liquid adhesive, which dries to a clear, permanently tacky film.

Usage / Purpose

Tremco SF200 Carpet Tile Tackifier has a multitude of uses, but has been specifically developed for use on:

- release bonding of Hexphalte/ Bitumen backed carpet tiles
- some grades of PVC backed carpet tiles and thermoplastic hot melt backed tiles
- underfelts

LIMITATIONS

Do not use in cold/damp conditions or where temperatures below $+5^{\circ}C$ are possible.

Colour

White (wet), Clear (dry).

Tremco SF200 Carpet Tile Tackifier complies with the requirements for low VOC emission products.

Composition

Tremco SF200 Carpet Tile Tackifier is a white acrylic polymer emulsion.

USAGE GUIDELINES

Standards

All aspects of the installation must be in accordance with the requirements of BS8204, BS8203 (Installation of Resilient Floorcoverings) or BS5325 (Installation of Textile Floorcoverings) and supplementary specifications.

Surface Preparation

- Site conditions MUST comply with British Standards CP 102, BS 8203, BS 5325 and supplementary specifications.
- The surfaces must be sound, clean, dry and free from oil, grease, paint, dust and other contaminants liable to impair adhesion.
- Concrete and sand/cement screeds must be fully cured and free from laitance.
- Direct to earth subfloors must incorporate an efficient damp proof membrane.
- Underfloor heating must have been fully commissioned as per manufacturers instructions and must be switched off 48 hours before and during installation. The heating should be switched on 48 hours after completion but then only gradually as per the commissioning schedule. Consult the Technical Department for a full specification.

Priming

Very porous or dusty surfaces should be primed with a thin coat of Tremco SF200 Carpet Tile Tackifier adhesive.

Method of Application

- The adhesive must be thoroughly stirred before use.
- Spread a uniform coating of the adhesive using either a lambswool roller or brush and allow to dry until it takes on a clear apperance, when the adhesive become tacky.
- Carpet tiles should be placed into the tacky film of adhesive, press firmly from the centre outwards to exclude air and to ensure overall contact.
- During the curing period, the adhesive must be kept free of dust and be undisturbed until the floor covering is placed in position.
- Remove and replace existing tiles. The back of the carpet tiles which have to be lifted and replaced shoud be coated with Tremco SF200 Carpet Tile Tackifier and allowed to dry before placing into position.
- The subfloor must be free of all contaminants and loose particles.

Coverage Rate

7 to 9 m²/litre

Cleaning

When not in use, wrap the paint roller in a polythene bag. Exclude air to prevent the adhesive from setting/drying on the roller. Stand the roller in an upright position so as not to subject it to any pressure. The roller will then be suitable for further application.

Clean tools, etc., with warm water when wet. Use Tremco AW421 Heavy Duty Cleaner (flammable) when dry.

Storage

- Store between +5°C and +27°C.
- DO NOT ALLOW TO FREEZE.

12 months when stored as recommended in original unopened containers.
