SECTION 2 - PHYSICAL DATA

Solid sheet or tiles with a slight characteristic odour.

SECTION 3 - COMPOSITION

Consists of stabilised, plasticized polyvinyl chloride containing some inorganic fillers and pigments.
Contains no hazardous ingredients.

SECTION 4 - HEALTH HAZARDS

SECTION 5 - CHEMICAL PROPERTIES

These products are not corrosive, irritant, toxic or oxidising agents. They are not reactive chemically.

SECTION 6 - FIRE HAZARDS

Will burn in the presence of flame and heat, upon removal of flame and heat the products are self extinguishing. The gases produced during combustion are mainly carbon monoxide.

In use and in line with other smooth floorcoverings, those extra resistance to slipping under wet conditions. Safety shoes are recommended for use when handling and installing all products.
